This is not mere investment. Every investor legally becomes a shareholder of the specific business that is invested into. The shareholding process is duly completed at the Office of the Registrar of Companies.

Product 2. Holding Business Investment

What is Holding Business Investment?

This is a product for equity partners to invest into special purpose limited liability companies for the purpose of aggregating resources for profitable commercial projects and businesses.

How does it work?

Choose a holding business and proceed with capital contribution to be followed by amendments at the Office of the Registrar of Companies (only GDPGH INVESTMENT LIMITED is currently available).

How much can you invest?

Holding Business Investments require a minimum of 1,000 Cedis.

How much returns can you expect?

Equity investments do not come with guaranteed or fixed returns but our holding businesses return not less than 31% per annum.

How is your business investment secured?

This is not mere investment. Every investor legally becomes a shareholder. The shareholding process is duly completed at the Office of the Registrar of Companies.

Product 3.

Vetted Business Investment

What is Vetted Business Investment?

This is a product for equity partners to invest directly into third-party businesses profiled for fundraising via equity partnership or equity crowdfunding.

How does it work?

Choose your preferred business, access further details from Propartners and proceed to back the campaign of the issuer (guided by provisions from SEC)

This is not mere investment. Every investor legally becomes a shareholder of the specific business that is invested into. The shareholding process is duly completed at the Office of the Registrar of Companies.

Product 4.

Short-Term Partner Investment

What is Short-Term Partner Investment?

This is a product for equity partners to invest directly, on a profit sharing arrangement, into transactions lasting for a couple of months. Partners do not become shareholders.

How does it work?

Register your interest as Short-Term Partner and deals would be communicated as and when they become available.

How much can you invest?

Short-Term Partner Investments usually require not less than 20,000 Cedis.

How much returns can you expect?

Equity investments do not come with guaranteed or fixed returns but our short-term transactions return not less than 15% over six months.

How is your business investment secured?

Short-Term Partner Investments are usually very risky and require extreme due diligence by Propartners before the transaction is profiled.

Product 5.

Portfolio Partner Investment

What is Portfolio Partner Investment?

This is a product for high net worth equity partners to invest in a portfolio of several businesses across sectors.

How does it work?

Register your interest as Portfolio Partner and your portfolio would be designed with your input and created as a special purpose holding business to be managed by Propartners.

How much can you invest?

Portfolio Partner Investments usually require not less than 500,000 Cedis.

How much returns can you expect?

Equity investments do not come with guaranteed or fixed returns but our Portfolio Partner Investments usually grow your wealth two to three times in seven years.

How is your business investment secured?

This is not mere investment. The Portfolio Partner legally becomes the principal shareholder of the special purpose holding company established to manage the portfolio. The shareholding process is duly completed at the Office of the Registrar of Companies.
